

**Habitat for Humanity of Spartanburg
VOLUNTEER WAIVER OF LIABILITY & PHOTOGRAPHIC RELEASE**

--To be read and signed by all persons intending to do volunteer work for Habitat for Humanity --

Waiver of Liability: I, for myself and on behalf of my dependents, heirs, assigns, personal representatives and next of kin, understand that volunteer work at Habitat for Humanity of Spartanburg will expose me to various risks of injury or illness including serious injury or potential death. Volunteer work includes work at or about a Habitat construction site; work at or about the Habitat Restore; work at the Habitat administrative office or work at any Habitat for Humanity of Spartanburg sponsored event. This waiver includes all activities and functions performed in these volunteer work areas. I understand and assume these risks and agree not to hold Habitat for Humanity of Spartanburg or Habitat for Humanity International (collectively known as Habitat), their agents, employees, members of its board of directors, or volunteers liable for such injury or illness. I certify that I am 16 years of age or older. I further certify that I will follow all safety rules, customs, and directions for all volunteer activities. In consideration of being permitted to participate in volunteer activities, I PERSONALLY AND VOLUNTARILY ASSUME ALL RISKS, known and unknown, that are a part of, or are incidental to any activities relating to travel to and participation in volunteer activities with Habitat for Humanity of Spartanburg, its parents, partners, affiliates, agents, employees, members of its board of directors, volunteers, or assignees and HEREBY WAIVE, RELEASE, AND FOREVER DISCHARGE HABITAT FOR HUMANITY OF SPARTANBURG, its parents, partners, affiliates, agents, employees, members of its board of directors, volunteers, or assignees, FROM ALL CLAIMS, LIABILITIES, LOSSES, DAMAGES, OR COSTS TO PERSON OR PROPERTY OR OF ANY OTHER KIND, WHETHER CAUSED BY ANY OF THE FOREGOING PARTIES' NEGLIGENCE, MY PARTICIPATION IN VOLUNTEER ACTIVITIES, OR BY ANY OTHER CAUSE.

Photographic release: I, for myself and on my behalf of my, dependents, heirs, assigns, personal representatives and next of kin, grant and convey unto Habitat for Humanity of Spartanburg all rights, title and interest in any and all photographic images and video or audio recordings made by/for Habitat for Humanity of Spartanburg, including but not limited to, any royalties, proceeds or other benefits derived from such photographs or recordings.
